The defendant Ham did kill a estimated four month old puppy by placing a sock in its mouth placing it in a trash bag and leaving it in a dumpster

Ham resides at 3024 Collegewood Dr #224 with is roommate Kimberley Teele Ham explained he had bathed the puppy and then left the residence thereafter the puppy as assumed missing Ham later admitted to the death of the puppy in a consensual interview in the hallway of the apartment complex and stated the incident was accidental

Ham explained the following he had been taking the trash out of the second story apartment and the puppy and darted out the open door Ham pursued the puppy to the first step of the staircase attempting to grasp the puppy under its hindquarters Due to the puppy's size (approximately eight pounds) the puppy slipped out of his grasp as he pulled backward causing the puppy to be tossed upward The puppy landed at the bottom of the steps on its head and neck Ham said the puppy began to bleed from the mouth and twitched Ham explained he took the puppy upstairs bathed it to remove the blood in an attempt to revive it Ham said the puppy when rigid and he presumed it dead Ham said the puppy continued to bleed from the mouth and he placed a sock in its mouth to block the bleeding so it would not drip onto the carpet as he disposed of it in the garbage can Ham tied the bag and removed it from the residence leaving on his bicycle and later placing it in a dumpster behind the plaza of 3680 N Wickham Rd which is located within two miles of his residence The bag was later seen moving inside the dumpster by a Bizarro Pizza Resturant employee Corey Hires who reported the incident to animal control

The puppy later expired at the Melbourne Animal Clinic and was examined by Veteranian Dr Barchird who determined the cause of death to be asphyxiation

Ham was taken into custody and transported to Melbourne Police Department for booking before being transferred to Brevard County Sheriffs Office for transport to Sharpes
