One dog tied to rope out backyard, the other is tied to doorknob of front door (dog is inside the residence)  
also Officer states possible litter or pups inside. I will be checking conditions and issuing appropriate citations. Owner did not show and so left door tag with instructions.

It appears we received another activity on this about 10 dogs. Well there are only 2 dogs. Owner already made contact and advised he needed some time for shots. Everything the same 2 dogs out in yard appears food and water, however house still appears abandoned. Owner would not give a contact number so waiting a few days to hear. Dogs are not distressed. Appears more of a barking matter, however Ofc. Bray did advise it is hard to find this owner. Will continue door tagging and if no reply will advise owner I will treat this as an abandonment if he refuses to get with me.

Per #46, give this owner week for shots.

**08/31/2009** Harris #33

Arrived met with Landlord. Called owner whom came within seconds. I asked him to standby until Inv. Anderson arrived. He grabbed his dogs and fled. Within minutes TPD arrived and gave them License number. They pulled owner over at Deleon and Pine where I then met Inv. Anderson. Owner Mr. Johnson was taken into custody, hence impounded Navy Seal (brown pit) for investigative hold. With owner was Janice Lowder, whom signed one of her dogs over. (Red). Inv. Anderson issuing cites at this time to Ms. Lowder. I then was asked to go down to the police station and write a statement. I met with Cpl. Hickey wrote statement. Inv. Anderson completing investigation, unless he needs further help from me.

I responded to the intersection of Pine and Deleon to assist Titusville with a possible animal cruelty issue the observed during a traffic stop.

When I arrived at the location there was two officer that had stoped a white car for a moving violation and while doing so they came across two dogs in the back seat and one dog locked in the trunk of the car with not water. I observed a small tan and white pit bull mox that appeared to very overheated it was panting very healvily and was hot to the touch. The owner stated that he had just put the dog in the car a few minutes ago but based on the fact that I had just spoken to him about the complaint at his house with two abandon dogs and he got very upset with me saying that I did not need to speak to him and that he was not going to meet with me at the house and that I would not see the dogs again I knew he was going to go by and take the dogs and leave. I had Officer Harris respond to try and keep him there until I was able to get there. Officer Harris observed Mr. Johnson pull up to the house and place two dogs in the back seat and never seen him place the other dog in the trunk I beleive the dog was in there much longer than the owner said.

The owner was placed under arrest for Felony animals cruelty and I took the dog from out of the trunk and the dog that was int he back seat and the one that was in the truk and took them into custody pending the out come of the petition for ownership
