Arrived on scene and spoke with Sgt. Warren with the Titusville Police Department. He advised that undercover officers were working area and notice a puppy in a carrier in the front of 505 Olive. Officers checked on the dog and it appeared to be in "bad shape". They removed dog from carriers and made contact with Animal services. While onscene, was approached by neighbors who stated that dog does not belong to address and someone has been bringing dog over early in the morning and picking dog up in afternoon. I spoke with a Kenyatta Brown who said that puppy was taken away from someone to help get the dog healthy again. I observed a rottwieller puppy lying in the soft sand. Dog was thin, except for intestinal bloat, and lethargic. No food or fresh potable water was seen. No one officially claimed ownership and statements reflect that no one is the caretaker. On the date of 6/28/09 I responded to a dog fight in progress(at 505 Olive Ave, Titusville) reported by the Titusville Police Department(who requested assistance). When I arrived on scene, I made contact with Cpl. Hickey(Id# 781/k-7) and Ofc. Wemyss(Id#736), and was appraised of the situation(Cpl. Hickey was the officer who actually witnessed the canines being fought).

While on scene I witnessed a canine roaming untethered in the front yard of 505 Olive Ave. Upon approachign the canine, I noticed that it had three fresh puncture marks upon it's muzzle, and what appeared to be several older scars(See attached pictures). As the canine was unsecured(and free to roam) I captured the canine and placed it within my truck. After securing said canine, I then went into the back yard in the company of Ofc. Wemyss and observed several canines, some of which were in dog boxes(and one tethered outside, in the north east corner of the back yard). Several of the canines had old scars upon their bodies(in particular, one had what looked like an old eye wound, and another several old scars upon it's muzzle. See attached pictures), while others appeared emaciated(see attached photos).Few of the canines had water provided(and of those that did, the condition of said water appeared rancid) and no food was seen provided for any canine on the property. It was at this time I contacted Inv. Anderson(Id #40, our department's Cruelty investigator on duty), based on what I observed.

While awaiting the arrival of Inv. Anderson, a gentleman then arrived on scene claiming to be the owner of the property, and identifying himself as one "Mr.Jordan"(Confirmed by the Officers on sceneas the owner of the property). Mr. Wade then got into a discussion with Cpl. Hickey, and another Ofc(Ofc Sypien, id#746) during which I asked Mr.wade if it was ok if I went into his back yard and photograph the scene and canines. In the prescence of Ofc. Sypien, Ofc. Wemyss, and Cpl. Hickey, Mr.Wade gave his permission, and so I entered the backyard in the company of Ofc. Wemyss once again. It was during this time that I photographed the canines within the dog boxes, and the back yard in general.

Shortly after I finished photographing the scene, Inv. Anderson arrived. After briefing Inv.Anderson of the situation and it's developements, the investigation was then transferred over to his control.

**06/29/2009** Anderson #40

On Sunday June 28, 2009 I was dispatched to 505 Olive Street in the city of Titusville to assist Animal Enforcement Officer Hahn who was the first responding officer on scene.

I arrived on scene and spoke with Corporal Kevin Hickey of the Titusville Police Department he stated "I was in the area looking for stolen vehicles, when I heard some noise coming from the backyard of the house on Olive Street when I looked through the fence I could see three black males who were pushing there dogs together in what appeared to me as trying to make them fight. They scene my vehicle through the fence and took off running with two of the three dogs and dropped the leash on the third dog. He then tried to stop the people in question and they continued to run. Corporal Hickey explained that he then became very concerned with the remaining dogs on the property and do to the house not having a secure fence he was able to go into the backyard to check on the well being of the animals that were left. He noticed that there were six other dogs that were living in deplorable conditions and of the six three of which had no water and the other three had water that was filthy. He asked me to evaluate the remaining dogs on the property.

I entered the property through the unsecured fence and was able to evaluate each dogs condition as well as the over all living conditions and they are as follows.

In the very far left side in the corner of the fence was a emaciated black female pit that was tied to a very heavy logging chain and had no water wand no dog house for shelter she appeared to be slightly aggressive.(see photos)

The next place I went to was a cage approximately 6x4 and contained one adult female pit-bull mostly black with a little white on her the cage had feces from what appears to be a few days of build up and the dog had scaring all over her body it appeared to be old and untreated.(see photos)

**06/29/2009** The next place I went to was a cage approximately 6x4 and contained one adult female pit-bull mostly black with a little white on her the cage had feces from what appears to be a few days of build up and the dog had scaring all over her body it appeared to be old and untreated.(see photos)

The next cage was about 8x4 and was divided into two sections and contained two dogs in one section was an emaciated mostly black with a little white female pit-bull the cage had a build up of feces as well in the second section of the cage was a very healthy and large red and white male pitbull with no water and the cage had a build up of excessive feces.

In the last cage there was two approximately four month old puppies one was a male and the other was female both were under weight and the cage to appears to have not been cleaned in a while the water bowl was dirty and full of some sort of debris.

After my evaluation of the dogs a black male came up to me to ask what was going on. I asked him why he was concerned he stated that these are my dogs and wanted to know why we were looking at them I started to ask him questions and he became very irate and did not have anything to say.

I asked him who was caring for the dogs he said he was. I asked for vet records that would indicate that they were his dogs and that they were vaccinated he said he gives his dogs shot himself from the feed store.

I then meet with Corporal Hicky and discussed my evaluation of the animals and at that point Corporal Hicky made a decision to place the owner under arrest for animal cruelty and based on the animals conditions and the living conditions all the animals were removed form the property and taken to the South Animal Care center where the will be held pending a hearing based on the state statue 828.073
