06/30/2009 Per TPD dispatch, her Lieutenant and other officers are on scene, but they are on a secure radio frequency so AEO will have to come up on County wide for TPD and the dispatcher will be monitoring same and relay information to the officers on scene.

07/01/2009 Anderson #40

On Tuesday June 29, 2009 I was dispatched to 610 Tropic Street in the City of Titusville. I made contact with the Corporal Kevin Hickey who was the officer that called our department. He stated "We served a search warrant this morning and during our investigation we located four dogs in the backyard of the residence that were living in deplorable conditions and when the owner is identified they will be arrested for animal cruelty".

I walked to the backyard with several officers that were already on scene and had the house secured and in the back yard there was a very large dog kennel approximately 12'x 4' and it was divided into three sections and in one of the sections of the pen was a blue female pit-bull who was confined inside a 3'x 4' section and inside this area was an excessive amount of dog feces with no place for the dog to sit down or lay down without being in the feces.

In the second part of the pen was a female tan pit-bull that appears to be slightly underweight and living in the same type of conditions as I was completing my evaluation the police department place a black female under arrest for animal cruelty and based on the animals living conditions and the owner being arrested for animal cruelty the dogs were taken into custody and transported to the North Animal Care Center to be held pending the outcome of the investigation

All dogs have been placed on hold pending Fitness to own

07/10/2009 #21 Brown

On Friday July 10 2009 Robert Mitchell contacted this department . He was passed to me by telecom. He wanted to know why he could not get his dogs back since they have been on hold for 2 weeks. I looked in the notes and it appears we are going to try a "Fitness to Own" petition to the courts. However no names were in the call and I could not determine if Mr. Mitchell was the person or if we had identified the owner of the animals in question.

I told Mr. Mitchell that the investigating officer would be back on shift on Sunday and if he would give me his number I would have him call and attempt to solve his problem. Mr. Mitchell became verbally combative and started to use strong language. I told him we would not continue the conversation if he persisted in this type of behavior. He shouted some offensive names at me and terminated the call.

07/12/2009 Anderson #40

I attempted to make contact with Mr Mitchell and was not able to do to the fact that the house is now empty The neighbor stated that they moved out last week and doesnt know where they moved to and unless we can get incontact with him the dogs will be considered abandon

07/14/2009 Anderson #40

No one lives at the address where the dogs were taken from I left a notice for the owner at a possible relatives house to try and make contact

07/15/2009 Anderson #40

I released the dogs back to a rerelative and since there was an arrest made I cannot write any citations

07/22/2009 #13 L Whiting

I spoke with Mr. Mitchell regarding why he did not have the money to get his dog back. Animal Services had agreed to cut the fees on the dog from \$165 to \$100 for the owner to get the dog back and make partial payments on the remaining amount. I spoke with Amanda Watson on 7/15/09 about this dog, Calli and the other dog, Ziggy that it was \$100 for each dog.

07/22/2009 Anderson #40

Spoke with the family member and advised him that he had until close of business today to claim the animals and then they will be county property
