I arrived on scene and Molly came out of the front door of the trailer. The door appears to be propped open. Molly's condition was severe. Neglect and suffering is present. The skin was inflamed and bleeding. Molly has hair loss and she was constantly moving and scratching to obtain some relief. When she would shake, you could see pieces of her skin coming off. I spoke with residents in the trailer park and both advised that the owner was at seen the residence today.
I called Animal Medical Clinic and asked that they fax over medical records to Animal Emergency Medical Care.
I spoke with Capt. Brown and he advised to pull the canine, Molly for immediate medical care. I posted the property advising the owner to contact Capt. Brown or myself. I called Palm Bay Police Dept. and asked for assistance.
Ofc. Bill Andrea #154 arrived and stood by while I removed Molly from the yard.
I transported the canine to Animal Emergency Clinic for treatment.

At 5:10pm the owner phoned me and advised the canine's skin condition started "acting up again" last week.
He provided the last of the medication that he had. I informed him that she was being treated and I could meet him at home around 5:30. He stated that was fine. That he was at a bar on US 1 using thier phone.
I then contacted Ofc. Bill Andera and set up a meet time with him to proceed to the owners home for the arrest.
I contacted Corp. Healy and advised of the situation.

Arraignment scheduled for 2/16/10 at 8am before Judge Burger at Viera Courthouse.
