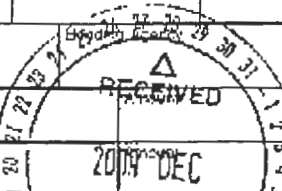

On the above date and time, I responded to 2731 Park Lane at the request of Brevard County Animal Control to meet with a suspect in a possible case of animal cruelty. Also responding was Ofc. M. Smith, ID 20. I had responded with Animal Control Officer Denise Karlton several hours earlier to the same address, as she had advised at that time that she was going to take an alleged neglected dog into custody. At that time, I stood by with Ofc. Karlton while she took about a 60 lb. dog and placed it in her Animal Control truck. I observed the dog with puss coming from it's eyes and nose, open wounds or sores on it's sides, what appeared to be mange of some type, and large patches of fur missing. When called by Ofc. Karlton, the dog appeared to struggle to walk to us, and seemed to be in great pain. At that time, I did not

observe any food or water visible for the dog, although the door to the home was open and the dog may have had access inside. The owner of the dog, ID'd as David Grant Van Schaick, was not home at that time. Ofc. Karlton immediately took the dog to an animal critical care emergency clinic, and reported to me that the veterinarian believed the dog to be suffering from severe neglect. Ofc. Karlton made arrangements with Mr. Van Schaick to meet at his home, and I accompanied her there. Ofc. Karlton informed me that she had originally been to the Van Schaick home several months earlier, and had tried to help arrange for low or reduced cost care for the dog, but that the offer had not been acted upon by Van Schaick. I questioned Van Schaick about his care for the dog, and believing that the dog had suffered great pain and suffering through the neglect of it's owner to seek veterinary care, I placed the defendant under arrest for animal cruelty. Van Schaick was transported to P.B.P.D. for booking, and TOT'd to desk booking and later B.C.S.O. Case is cleared by arrest.
