
On 01-04-08, Thivierge initially contacted the defendant at 1652 Sunhome about her dogs. The defendant's dogs recently gave birth to several puppies who were allegedly being mistreated. At that time, I observed the puppies who were in poor condition. Their fur was very patchy and they appeared to be covered in mange and fleas. Animal control officers apparently warned the defendant at that time.

On this occasion, while the animal control officers were conducting their investigation, I observed the four puppies they seized. Each puppy was covered in mange and fleas. When the animal control officers picked up the puppies, they bled about the face. Their fur was very patchy and on some of the puppies, their hind area was void of any fur. The puppies' situation was dire. After further investigation, I learned that the defendant was advised by animal control officers about 2 months ago to care for her dogs. The defendant went to a vet on 01-15-08. The vet at that time told the defendant that the dogs were in such bad shape that she needed to get them treated professionally or have them put down immediately. The defendant never sought professional help and allowed the puppies to suffer. Animal control officers Anderson and Thivierge wrote affidavits. They advised that the puppies will most likely have to be put down due to their severe condition.

Pursuant to F.S.S 938.27 and F.S.S 775.089 the cost incurred was \$67.50

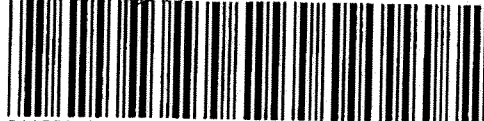

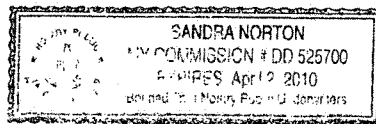

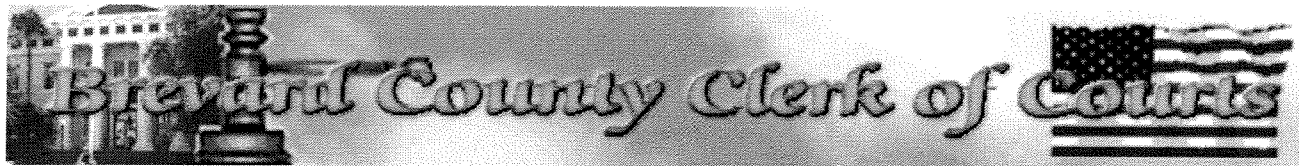
