STIPULATED FINAL JUDGMENT

THIS MATTER having come to be heard on the 30<sup>th</sup> day of November, 2009 upon Petitioner, BREVARD COUNTY'S Petition for Hearing to Determine Fitness of Owner to Care for Animals, the parties hereto having stipulated to the provisions set forth herein, and the Court having reviewed the file and being otherwise fully advised in the premises, it is hereby ORDERED and ADJUDGED as follows

1. Custody of the pit bull dog "Momma" described in Brevard County's Petition herein is remanded to Brevard County Animal Services and Enforcement,

2. Respondent/Owner KENTRA WYNS is hereby enjoined from further possession and/or custody of other animals until such time as Respondent/Owner affirmatively demonstrates to a court of competent jurisdiction that he is fit and able to have custody and/or possession of animals; and

3 Respondent/Owner shall pay costs for impoundment, transportation and veterinary care to Brevard County Animal Services and Enforcement in the amount of FOUR HUNDRED EIGHTY SEVEN AND <sup>00</sup>/100 (\$487.00) DOLLARS in twenty-four (24) equal monthly installments of TWENTY (\$20<sup>00</sup>) DOLLARS per month and one final payment of SEVEN (\$7<sup>00</sup>) DOLLARS, payable on the 10<sup>th</sup> day of each month commencing on January 10, 2010, at: 1515 Sarno Road Bldg A, Melbourne FL 32935.
